

## **Assumption of the risk & Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend a social distancing and have, in many locations, prohibited the congregation of groups of people.

Jeepers Jamboree & Jeep Jamboree, Inc (the "Corporation") has put in place preventative measures to reduce the spread of COVID-19; however, the Corporation cannot guarantee that you, your family or your guests will not become infected with COVID-19. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself including, but not limited to; personal injury, disability, and death, as well as illness, damage loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at or participation in the Event and my contracting COVID-19 or any symptoms related thereto ("Claims"). I hereby release, covenant not to sue, discharge, and hold harmless the Corporation, as well as, any of its partners, officers, employees, agents, representative or volunteers from any and all liability, directly or indirectly, under any theory of law (contract, tort negligence or otherwise), available to me or anyone else, for any liabilities, claims, action, losses, costs and expenses of any kind (including reasonable attorney fees) or damages (including direct, indirect, special, incidental, punitive or consequential) resulting from or occasioned by my attendance at or participation in the Event and contracting COVID-19 or any symptoms related thereto. I understand and agree that this release includes any Claims based on the action, omissions, or negligence of the Corporation its partners, officers, employees, agents, representatives or volunteers, whether a COVID-19 infection or the appearance of any symptoms related thereto occurs before, during, or after my attendance at or my participation in the Event.
